My name is Shelley Wilson and together with my canine girls, Ruby and Charlotte we volunteer at Surrey Memorial on the Tertiary Palliative Care Unit. Ruby (right) and I have been visiting up there for 5 years, Charlotte (left) is Ruby's daughter and joined in as soon as she turned 1 about 18 months ago.

Many years ago my husband spent weeks in the hospital while fighting cancer. Whenever the dogs showed up on the ward, David's eyes would light up. It was the high-

light of his day. I just knew when the time was right, and the dog was right it was something I had to do. So when Miss Ruby came along I contacted Pets and Friends. In no time at all I found myself at their volunteer training night. I never really gave much thought to where I wanted to volunteer, but then hospice came to mind. It seemed like the perfect match.

At N52 Leila, the unit clerk, calls it Ruby Tuesday. Ruby runs in as if it's her second home. Charlotte drags Leila to the cookie cupboard where we start out with tricks and treats. Its giggles all around as everyone enjoys pets and love, staff and dogs alike. Each patient visit is different. Some include tricks, some cuddles on beds, some walks outside. Then there are some who the dogs lay quietly beside the bed as family and friends enjoy their presence. We, the humans chat about all sorts of things.

Tuesday afternoon is a highlight in our week. People ask me how I do it, how I can be around people dying all the time. I tell them I am not. I am around beautiful, living people that just happen to know their end is near. I tell them that I have the most amazing opportunity to learn from them and support them on this journey.

## **Bedside Singers**

Surrey Hospice Society is excited to offer our Volunteers a new modality of care: Bedside Singing.

The Vancouver Threshold Choir will be visiting our Resource Centre to conduct a 5 hr. Introductory Workshop, Saturday June 24<sup>th</sup>.

Bedside Singing is done a cappella (voices unaccompanied by instruments) and generally in teams of 2 -4 singers. The goal is to bring ease and comfort to those at the thresholds of living and dying. A calm

and focused presence at the bedside, with gentle voices, simple songs, and sincere kindness, can be soothing and reassuring to clients, family, and caregivers alike.

The repertoire of Bedside Singing includes songs of comfort and general blessing, as well as some familiar songs from popular culture. This range allows singers to offer a choice of either relaxing or upbeat songs during visits to match the kind of support that is needed at any particular time by the client or their family.

Jan Alexander, Program Director of the Vancouver Chap-



ter of The Threshold Choir (www://thresholdchoir.org/) will be leading the training with our Hospice Volunteers. Jan has assured us that no audition or professional training is necessary to become a Bedside Singer but asks that singers are able to stay on key, or open to learning how. Songs are generally sung in a warm lullaby tone. Singers will practice blending their voices together with one another.

The Introductory Workshop will be a great experience for those who are certain they would like to become a Bedside Singer and also for those who need more information and experience before deciding.



On February 28<sup>th</sup>, 2017 the Community Thrift Store was awarded the "Serving with Distinction Award" from the Surrey Cares Foundation for "Social Innovation". The store is run by both the Surrey Hospice Society and the Surrey Fire Fighters Charitable Society which has been a part of the Newton community since 2005. All profits from the store go back into the community by providing hospice support and funding for the Firefighter's charitable programs.

The store is staffed with over 75 volunteers, many of whom have been part of the Thrift store since it opened. The store offers training to various organization within Surrey by providing their clients with opportunities to gain experience and build confidence in the workplace. They also associate with organizations that provide people with disabilities work placement, helping them to develop new skills and overcome social barriers. Many of our volunteers are seniors, students, and others who just want to give back.

The store serves as an affordable alternative for people in our community. A great big thank you and congratulations to the Community Thrift Store Manager, Donna Chubb and all our dedicated volunteers!
